

# PETE (PITA) MALAE

In 1964 Pete (Pita) Malae graduated from Waipahu High School in Waipahu, Hawaii. Upon high school graduation, Pete followed his brother Faulalogofie (Jack), and enlisted in the Army in 1965. Pete was trained and assigned to Company C, 1st Battalion (Airborne), 503d Infantry Regiment, 173d Airborne Brigade, a Special Warfare Unit. During the years of 1966-1968 Pete served in Vietnam. During this time, Pete received numerous awards for his service. This included a Silver Star with valor, two bronze stars with valor, and a third bronze star. To say Pete served honorably, is an understatement.

This silver star citation stated on September 27, 1968, while serving as a machine gunner with Company C, 1st Battalion (Airborne), 503d Infantry Regiment, 173d Airborne Brigade. On this day Company C encountered a heavy volume of automatic weapons fire from a Battalion-sized North Vietnamese Army base camp with fortified and well concealed bunkers. As the point platoon maneuver to gain fire superiority, the second platoon moved to form rear security. In the three-hour engagement that followed, both friendly and enemy forces began taking a number of casualties. It became evident that a defensive perimeter would have to be formed. Specialist Malae, realizing this and seeing that first platoon was unable to move because of the intense enemy fire, secured his machine gun and moved down the hill with the tracker team to the point of initial contact. He set up his machine gun in a critical position so he could put effective fire on the enemy. He received credit for killing an estimated fifteen enemy soldiers. During the action, Specialist Malae's assistant gunner was wounded, and he left the gun long enough to pull the injured man to safety. His courageous actions were responsible for saving the company from taking more casualties. Specialist Malae's extraordinary heroism was in keeping with the highest traditions of military service.

Upon his return, Pete attended Westfield College in Coalinga, California and played on the school's football team. Pete was then recruited to play football for Santa Clara University. The person that recruited Pete was Bill McPherson. McPherson later became a defensive coach for the San Francisco 49ers. During McPherson's time with the 49ers, he either coached or was an executive for the teams 5 Super Bowl winning teams.

After Santa Clara University Pete was hired at SCPD. Pete was a founding member what was to become the SCPD SWAT team. Pete was the original "E-1." Pete utilized the training he received in the military to train other team members. This added to numerous successful operations with no loss of fellow teammates.

Not only did Pete set the framework for SCPD SWAT, but he was instrumental in the development of the Santa Clara Police Motorcycle Unit. Pete joined the unit in 1979. Pete either trained or had significant influence in the training of new riders from 1980 to 2004 when he retired. Even after Pete retired, Pete would assist the new police motorcycle instructors in the development of Police Motorcycle operators. Pete rode a Police motorcycle for 25 years; this will never be accomplished again.

Pete Malae's impact to the Santa Clara Police Department is unprecedented. Many of the training techniques developed by Pete for the SWAT team and Motorcycle operators are still trained today. Pete Malae's teachings has added to the safety of Officers both in SWAT and in the Traffic unit. It is this reason and others that I am requesting the Police Motorcycle garage be dedicated to Pete Male. This will recognize his contributions long after many of our careers.
